Dear Sir:

The following report of the Military and Naval Department is submitted in accordance with Section 26, Article IV, Military and Naval Code of Illinois, approved 8 July 1957, and covers the period between 1 November 1960 and 31 October 1962.

During this period two important events have occurred in the Illinois National Guard.

During the month of October, 1961, units and members of the 128th Ordnance Company, Quincy, Illinois, the 3637th Ordnance Company, Springfield, Illinois, the 169th Tactical Fighter Squadron (Special Delivery), Peoria, Illinois, and the 170th Tactical Fighter Squadron (Special Delivery), Springfield, Illinois, were called upon by the President of the United States for duty during the Berlin Crisis. These units were released to State control during the month of August 1962.

In addition to the call-up during the Berlin crisis, the Air National Guard has undergone a reorganization which has converted the 126th Air Defense Wing to the 126th Refueling Wing, converting from Jet Type Aircraft to KC 97 Tankers.

Their primary mission is to refuel Jet Aircraft while in flight. After months of intensive training, the first in-flight refueling by an all Air National Guard crew was accomplished in April, 1962.

The State Military Forces, attained their highest degree of efficiency since the Korean conflict and are highly capable of accomplishing their Federal and State mission.

SECTION I

SECTION IIADMINISTRATIVE BRANCH

The Chief, Administrative Branch is, in addition to duties incident thereto, designated Executive Officer and, in the absence from the State or otherwise, of both The Adjutant General and the Assistant Adjutant General, he will act therefor in accordance with established policies.

He also performs such other duties as may be assigned by The Adjutant General or the Assistant Adjutant General, which include the following:

Liaison and co-ordination with Facilities and Maintenance and Property Branch Chiefs relative to matters pertaining to the operation of their branches in co-ordination with other branches. Primarily this pertains to armory deficiencies, use of facilities and property and construction projects which effect operations of other branches.

All matters relating to the accounting of Federal property requiring action by The Adjutant General, other than those which are the responsibility of the United States Property and Fiscal Officer.

Co-ordination and preparation of reports of The Adjutant General, including the compilation, writing, assembling, reviewing and editing of material for publication.

Compilation of statistical data and conducting studies relative to armories, real estate, ranges, storage facilities, and recommendations for utilization of facilities.

Administration and review of all annual general, armory, ordnance, maintenance, and other inspections except field training.

Administration relative to bonding of commanding officers and custodians.

Responsibility (custodian) for security files in accordance with AR 380-5.

Special investigations relative to security matters.

Review and disseminate weather data and river stages as required.

Cryptographic matters.

Review, authenticate, and process requests for State of Illinois license (AGO Ill. Form No. 96) for Army, Navy, and Air personnel.

- Dissemination of teletype messages to proper branches.
- Special projects as directed.
- Review and process requests for State funds as authorized for active duty, range firing, etc.
- Review applications for Security Investigations of personnel of the Army National Guard.
- Review and supervise distribution of State publications. Co-ordinate distribution of Federal publications with United States Property and Fiscal Officer when required.

SECTION III

MILITARY PERSONNEL BRANCH (ARMY)

The Chief of the Personnel Branch (Army) is responsible to The Adjutant General for the operation of the Administrative Section; Officer and Special Orders Section; Enlisted Section; Machine Records Section; and School and Service Records Section as pertains to the Illinois Army National Guard and the Illinois Naval Militia.

ADMINISTRATIVE SECTION:

Responsible for the supervision and control of all sections of the Personnel Branch.

OFFICER AND SPECIAL ORDERS SECTION:

Maintain and process military records of Officers and Warrant Officers of the Illinois Army National Guard, the National Guard of the United States, and the Illinois Naval Militia, including efficiency

reports, appointments, promotions, separations, and service creditable for determining date of rank and date of relative rank.

Review and make appropriate recommendations on applications for Federal recognition of officers and warrant officers of the Illinois Army National Guard.

Recommend termination of Federal recognition in appropriate cases.

Process injury reports for Army National Guard personnel.

Check and review efficiency board proceedings.

Furnish legal information pertaining to the Illinois Army National Guard and Illinois Naval Militia on personnel matters.

Publish and distribute Special Orders.

Maintain file of Illinois Army National Guard and Illinois Naval Militia officers and warrant officers by name, grade, address and telephone numbers (home and business), and organization.

ENLISTED SECTION:

Process enlistments, promotions, separations, releases and active duty status of all enlisted personnel in the Illinois Army National Guard and Illinois Naval Militia.

Compile personnel enlisted reports.

Maintain active records for Illinois Army National Guard and Illinois Naval Militia enlisted personnel by name, grade and organization.

Process enlisted service records of Illinois Naval Militia.

SCHOOL AND SERVICE RECORDS SECTION:

Process applications for Service and Staff Schools for Illinois Army National Guard personnel.

Maintenance of Service Records for Illinois Army National Guard personnel.

Prepare Statements of Service for officers, warrant officers and enlisted personnel of the Illinois Army National Guard and Illinois Naval Militia.

Process applications for security investigations of Illinois Army National Guard personnel.

During the period covered by this report, the Military Personnel Branch processed the following:

Maintained roster of National Guard Table of Organization and equipment positions of officers and warrant officers.

Audited and maintained retirement credit points for all personnel separated from the Illinois Army National Guard.

Issued Special Orders pertinent to the administration of the Military and Naval Forces of the State.

MACHINE RECORDS SECTION:

The Machine Records Section acts as a control on all personnel activities of the Illinois Army National Guard, Illinois Naval Militia, and the Illinois Air National Guard, and maintains current data as follows:

Officers' and warrant officers' physical examinations, Military Occupational Specialty, National Guard Association membership, Reserve Officer Personnel Act, Federal Recognition, service numbers and Army Service Schools.

Enlisted men's flying status, Military Occupational Specialty, service numbers, type of prior service, six months active duty agreements, security clearances and Army Service Schools.

Furnishes machine records rosters and tabulations of officers, warrant officers and enlisted men, periodically and at other times as required. This includes Penching System, Reserve Officer Personnel Act, six months active duty and physical examinations.

Furnishes machine records rosters monthly of all enlisted personnel of the Illinois Air National Guard.

Furnishes property listings by armory of all State property as required.

Checks for accuracy, all orders on officers and enlisted personnel, and all requests for changes of status on enlisted personnel which appear on Military and Naval Department Orders.

SECTION IV

GENERAL FILES BRANCH

The General Files Branch is responsible for operation of the General Files Section; Historical Section; Mail Section; and Publications Section.

GENERAL FILES SECTION:

Maintenance of functional, decimal, and suspense files of The Adjutant General's Office.

- Outgoing mail originating in this office.

LIBRARY:

Maintenance and restocking of the office library.

HISTORICAL SECTION:

The Historical Section is responsible for the preparation and maintenance of histories of all past and present units and organizations of the State Militia.

Safekeeping of all military historical and archival records as pertains to the State of Illinois.

Safekeeping of all personnel records for all officers and enlisted members of the Illinois Army and Air National Guard and Illinois Naval Militia.

POSTAL:

Operation of Postage Machines.

Accurate Reporting of all postal charges.

PUBLICATIONS SECTION:

Distribution of publications prepared by or referred to this Section.

Maintenance of a log to record dates material is received, processed and distributed

Reproduction and the mimeographing of all publications emanating in the Office of The Adjutant General.

Conducting a continuous study for better utilization of all material arriving in a constant flow, and to make it available to all branches of the Military and Naval Department for utilization and research in the daily affairs of the office. To this extent a continual search to eliminate any obsolete and duplicate material not essential to the operation of the Military and Naval Department is maintained.

SECTION V

OPERATIONS AND TRAINING BRANCH

The Operations and Training Branch is responsible to The Adjutant General for training of all units of the Illinois Army National Guard, to include the following:

Formulate plans and policies pertaining to the Illinois Army National Guard and Illinois Naval Militia.

Survey existing laws, regulations and directives pertaining to the Illinois Army National Guard and Illinois Naval Militia, and prepare studies on reorganization, conversion, and the reallocation programs in relation to the over-all plans of the Department of the Army, and Navy.

Prepare orders and training directives for the Illinois Army National Guard.

Prepare and maintain the State training program including Headquarters, Illinois Army National Guard.

Check and approve training programs and schedules of all major organizations.

Prepare and maintain the State Mobilization Plan.

Review and approve Mobilization Plans of all major organizations.

Review and approve plans and operation of Illinois Officers Candidate School.

Co-ordinate Special Security Forces operations.

Review applications for Army Service and Staff Schools.

Assessment of damage in State active duty operations and natural disasters.

Awards for proficiency of training and maintenance.

Range schedules.

State rifle team activities.

Mobilization and demobilization of units.

Missile program.

Co-ordinates support activities with Civil Defense.

ILLINOIS OFFICER CANDIDATE SCHOOL:

The Illinois Officer Candidate School was established on 1 June 1957.

This school is organized to train enlisted men of the Illinois Army National Guard to fill existing and future Second Lieutenant vacancies in the Army units of the Illinois National Guard.

The Program of Instruction offered is a balanced curricula of military subjects developed by The United States Army Infantry School, Fort Benning, Georgia.

The School is staffed by efficient, capable and experienced officers.

Intensive training, rigid standards of conduct and discipline, and an exacting manner of performance is demanded of the candidates.

The object of the school is to develop and train the highest type qualified enlisted men for appointment as future officers in The Illinois Army National Guard.

The Graduates of this school will be the leaders of the Illinois Army National Guard in the years that lie ahead, thereby preserving the great traditions and prestige of the National Guard. It is to this end that the Illinois Officer Candidate School is dedicated.

The training year is divided into two phases consisting of two (2) weeks at Summer Field Training and ten (10) week-end sessions conducted at Camp Lincoln, Springfield, Illinois.

With the initiation of the Illinois Officer Candidate School all commissions as Second Lieutenants in the Illinois Army National Guard with the exception of doctors, dentist, chaplains, and judge advocates, are limited to graduates of the Illinois Officer Candidate School, the Officer Candidate School of another State, the United State Army Regular Officer Candidate School or the United States Army Special National Guard Officer Candidate School.

Commission have been tendered to 279 Army National Guard Personnel through Class VI of The Illinois Officer Candidate School. Class VII which reported to the Commandant at Camp Lincoln, Springfield, Illinois, on 27 October 1962 is scheduled to graduate during the month of August 1963.

During this period individual trophies and awards were authorized to the three outstanding Officer Candidates of each graduating class. They are as follows:

ACADEMIC AWARD: The Academic Award was instituted at the inception of Class V of the Illinois Officer Candidate School. This award is presented by The Adjutant General of the State of Illinois to the Candidate who attains the highest scholastic average on all courses of the program of instruction as prescribed by the Infantry School, Fort Benning, Georgia.

LEADERSHIP PLAQUE: The Leadership Plaque is awarded to the outstanding Candidate of each graduating class who demonstrates the highest standards of leadership while undergoing the Officer Candidate Program.

ERICKSON TROPHY: The Erickson Trophy is awarded by the National Guard Bureau to the distinguished Candidate of each graduating class attaining the highest overall average of all phases of the program of instruction and leadership ability.
